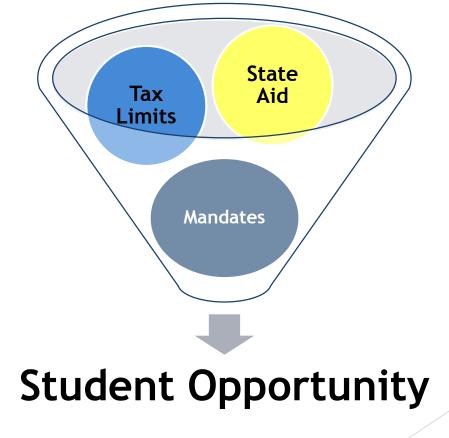

District goals served by budget process



Present and pass a budget that maximizes opportunities for students while controlling costs for district taxpayers. We must also be mindful of the State Tax Levy Limit and the impact of all the state mandates.





Financial Challenges

State Limit on Local Tax Income with the Tax Cap

The 2% Tax Cap in NOT 2%

- ➤ 2015-16 Year .65% Tax increase allowed \$35,119
- ➤ 2016-17 Year -.62% Tax increase allowed -\$33,523
- ➤ 2017-18 Year .52% Tax increase allowed \$28,031
- > 2018-19 Year 2.52% Tax increase allowed \$137,472
- Historically, Lyncourt averaged a 3% increase each year. That approximate increase in tax revenue was \$165,000.

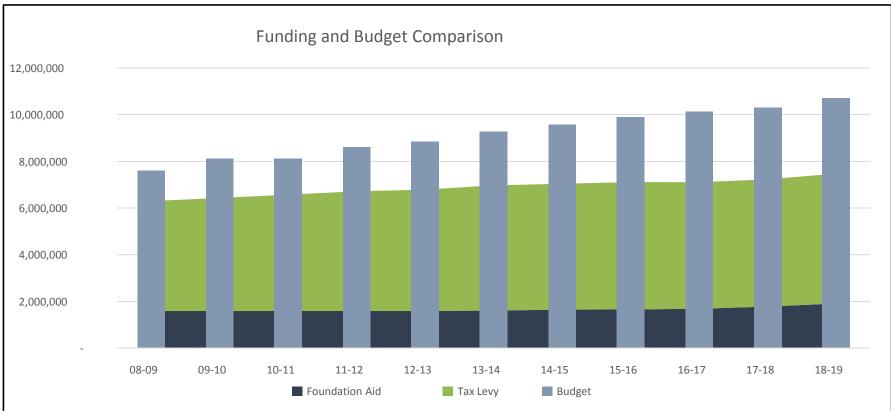

If State Aid increased this year, why do we still have a budget gap?

Although we have increased revenue available this year for the first time in many years, we still have a gap between our budget and our revenues. The gap has been created over years of tax limits and reduced and frozen funding. The gap created does not go away in just one "better" year.

Although we are responsible with our budget planning and have taken many measures to contain costs, costs do go up every year. The budget has continued to increase over the years while tax revenue has been limited and state funding has been stifled. The graph below depicts the steady growth of the budget gap. This gap will exist until we are fully funded, together with reasonable increased revenue that is equal to our necessary expenditure increases.

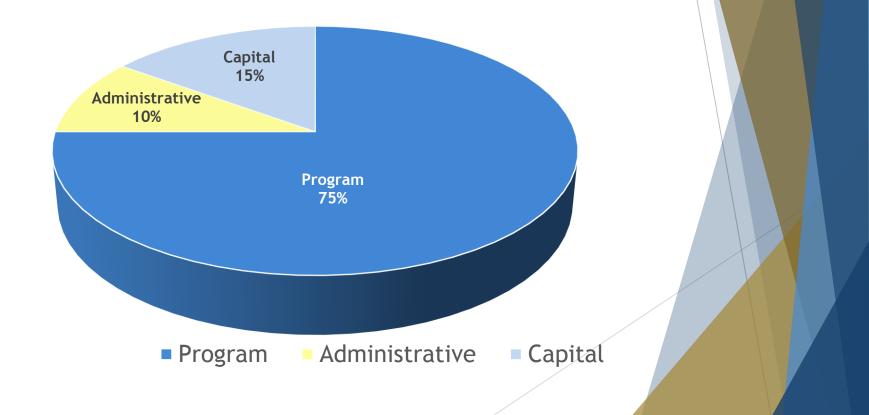

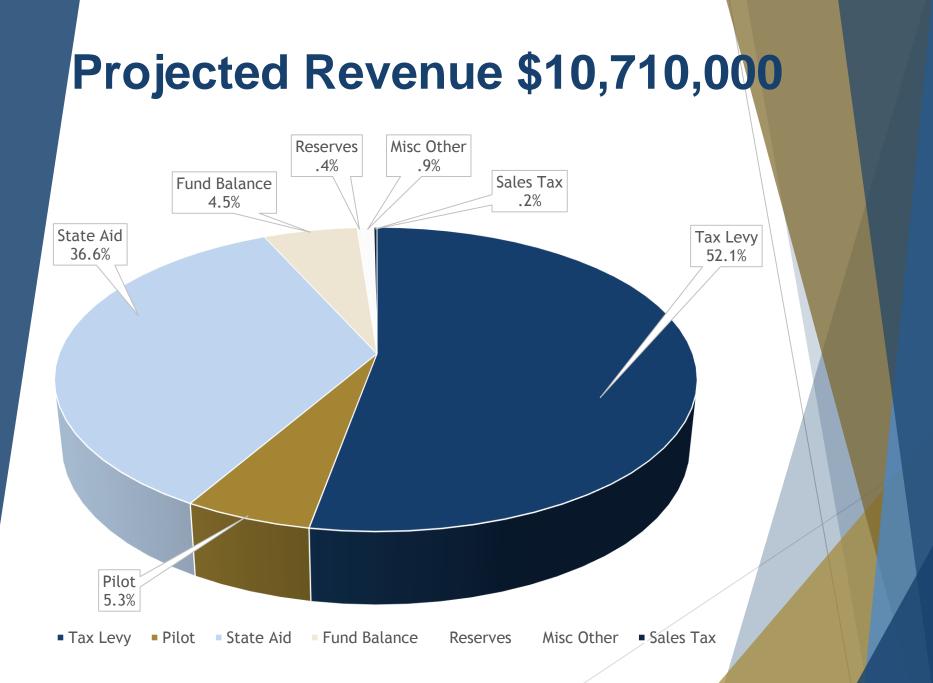

High School Choice, Why?

Research into other Pre-K through 8th grade public school districts in New York found they all have multiple high school options for their students. We believe in the benefits of giving our 8th graders a high school choice and are happy to now be able to offer this option for our students.

How will our students be transported to each high school?

Transportation for our students all the way through the 12th grade is Lyncourt's responsibility. We do not own buses, we contract with each district to provide transportation. Our students attending Solvay will be transported as usual. For those attending ESM, ESM will be providing transportation.

How will this impact Lyncourt middle school modified athletics?

Modified sports structure will remain the same. Lyncourt will have our own modified program and will partner with Solvay for all non-cut sports.

Will Lyncourt school merge?

No, we are our own public school district and plan to remain that way. We believe providing students with multiple high school options will only strengthen and enhance our Pre-K through 8th grade model.
