Message from the Board of Education

Dear Residents, Families, and Friends of Lyncourt School,

We are pleased to submit the 2018-2019 Lyncourt Union Free School District budget for voter approval. The Lyncourt Union Free School District Board of Education, as well as most other Boards of Education in NY State, have once again been faced with some very difficult decisions in creating a fiscally responsible school budget that puts our students, staff and community at the forefront. As always, we continue to focus on our *Mission* and the safety and success of our students to guide us in our decision-making progress.

The 2018-2019 budget development process considered the following significant factors: 1) increase staffing demands due to enrollment growth; 2) emerging students; 3) school safety; and 4) rising costs of contractual obligations and state mandates. Enduring these financial pressures has been daunting, but we are dedicated to keep our school, keep our programs, offer exceptional services to all of our students, and continue to be the hub of this community. Our class sizes remain small, our staff and class offerings remain current, our special education services provide remediation to all children in need of special support and we now offer multiple options for our prospective high school students. Lyncourt School is truly the best little school district in the country.

This brochure will provide you with details of our proposed 2018-2019 school budget. The budget proposed is \$10,710,000, an increase from 2017-2018 to 2018-2019 of \$406,000. This represents a 3.94% increase in expenses. Increases result from safety enhancements, contractual obligations, mandate implementation, essential technology updates, salaries and insurance. Our tax levy limit increase that is set forth by the state is 2.52%. This represents an increase in tax revenue of \$137,472. The state has increased foundation aid to the district this year amounting to an additional \$125,441. This increase is a result of our overall population growth as a district, which has increased by almost 19% in the last 5 years.

Although we are finally realizing an increase in state aid, the aid is still well below the expenditure growth we have each year. This reduced aid, coupled with property tax limits, leaves us with a financial gap every year. We again have taken the option of funding the budget deficit with reserves and fund balance, ensuring our residents qualify for the proposed state tax rebate. Our priority is to continue to provide a solid education for our children in a safe and comfortable environment. We have great expectations for the future of our community.

We sincerely appreciate the support we continue to receive from our Lyncourt community. We appreciate the partnership between school, community and every local business, and we are proud to present a budget that is fiscally responsible while providing opportunity and improved safety for our students.



Projected Revenue



Projected Expenditures

Capital Outlay Project: The 2018-19 budget includes a \$100k capital project or "mini project" for work consisting of renovations to create additional instructional space, including, but not limited to finishes, millwork, lighting, technology and furniture, at a maximum cost of \$100,000.00 with building aid expected from the state in the following school year.

What is the financial impact of adding East Syracuse Minoa (ESM) as another High School option?

Tuition for our high school students remains consistent with previous years. The Lyncourt Board of Education has secured multi-year contracts with both Solvay and ESM that include the same tuition calculation for both. This has mitigated large increases in tuition expense. Maintaining affordable high school costs for a quality education that is a good fit for the individual child is our top priority.


What does the school district do to reduce expenditures?

Lyncourt participates in several consortiums made up of a group of other schools and municipalities that pool our buying power and save money in areas such as health insurance, worker's compensation insurance and utilities. The district collaborates with other districts and shares services as we are doing with Solvay for our transportation and technology staff. We utilize BOCES to get aid on services and purchase off of cooperative bids, saving thousands of dollars each year.

What happens if the budget does not pass?

If a school district vote fails, the school board may put the same or a revised budget up for a second vote, or adopt a contingency budget. If a school budget fails twice, the district must adopt a contingent budget. Under a contingent budget there can be no increase in the tax levy and by law it would prohibit the district from allowing free community use of the school building, non-essential equipment and supply purchases, and cap administrative expenditures.

What is the difference between Tax Levy, Tax Rate, Tax Bill?

The **TAX LEVY** is the total amount of money the school district will collect through school taxes from local property owners to support the district budget. The **TAX RATE** is calculated by dividing the total tax levy into the total assessed value of all properties located within the district, coming up with a rate per \$1,000 of assessed property value. Property assessed values are determined by the Town Assessor. The **TAX BILL** is the homeowner's portion of local school funding. The bill is calculated by multiplying the property assessed value by the tax rate per thousand. A tax bill can fluctuate due to assessed value changes and exemptions an owner may qualify for. The school district does not have any control over the assessed values or redistribution caused by exemptions on properties.

Does the tax levy, or tax rate examples, indicate how much my tax bill will change?

No. These are hypothetical examples. Individual bills vary depending on each property assessed value, value changes and exemptions an owner may qualify for. The school district sets the total levy. The property values are set by the Town Assessor.

The annual budget vote for the fiscal year 2018-19 by the qualified voters of the Lyncourt Union Free school district, Onondaga County, New York, will be held at Lyncourt Union Free school in said district on Tuesday, May 15, 2018 between the hours of 7:00am and 9:00pm, prevailing time in Lyncourt School, at which time the polls will be opened to vote by voting ballot or machine.

1. The basic school tax relief (STAR) exemption is authorized by section 425 of the Real Property Tax Law.

Who can vote?

All qualified residents living in the Lyncourt school district can vote on May 15, 2018. A qualified voter must be over eighteen (18) years of age, a citizen of the United States, and a resident in the School District for thirty (30) days preceding the vote date. You do not need to own property in the district or be a registered voter. **You can vote if you rent, as long as you reside in the district.** Qualified voters who will be away from home and are unable to vote in person may request an absentee ballot from the School District Clerk. Absentee ballots must be received no later than 5 p.m. on the day of the vote.

Why is the Library Proposition part of our school district budget vote?

According to Section 259 of the Education Law, public libraries may request that a proposition be added to the school district ballot and tax collection. A Board of Education must place propositions requested from a local library Board on its annual meeting ballot. If the proposal is voted down, the annual library tax reverts to the previously approved annual levy.

VOTER QUALIFICATIONS—WHO CAN VOTE?

**You can vote if you rent and live in the Lyncourt School District.

ABSENTEE BALLOTS

Individuals interested in obtaining an absentee ballot for the upcoming school budget vote on May 15, 2018 may do so at the District Office during business hours, 8:00 a.m.- 4:00 p.m. Monday through Friday.

Qualified district voters must request in advance an application for an absentee ballot. The voter must complete the application and state the reason he/she will not be able to appear the day of the election. Requirements in order to obtain an absentee ballot are those involving an illness or physical disability, business responsibilities which require travel on the day of the vote, vacation, or students away at college.

If mailed, all applications must reach the District Clerk in the District Office no later than 5:00 p.m. May 8, 2018. If hand delivered, the application must be received by the District Clerk in the District Office by 4:00 p.m. on May 14, 2018. All Ballots must be received the District Clerk on the Budget Vote day before 5:00 p.m.
